

Charles H. Butler Memorial Pace General Conditions

Sponsor: Prairie Meadows Racetrack & Casino

For: Iowa Registered and/or Iowa Sired Four-Year-Olds & Older Aged Pacers in 2011 (Subject to USTA Foaling Date Rules).

Trophy: To be awarded to the winning owner(s) of the race.

To Be Raced As: One race for Iowa Registered and/or Iowa Sired Four-Year-Olds & Older Aged Pacers which is named The Charles H. Butler Memorial Pace.

To Be Raced At: Prairie Meadows Racetrack & Casino, Altoona, IA.

Payments: (U.S. Funds) One (1) nomination payment of \$100 is due on or before September 15, 2011. (See front of Nomination blank for payment instructions) Eligible nominations are determined by the time of actual receipt by the manager of the race, with a seven (7) calendar day grace period for slow and/or delayed mail delivery services. Payments received after the grace period that have U.S. Postal Service marks, or express delivery service billing receipts dated prior to the advertised deadline may be accepted at the sole discretion of the manager of the race. Returned or insufficient fund payments may be an automatic withdrawal from the stake race (all payments made to date will be forfeited). To be re-eligible a payment of Supplemental Nomination Fee plus Nomination Fee, and Entry Fee must be made with cash, money order, or certified check.

Entry Fee: An Entry Fee of \$50 will be due at time of entry. Failure to draw into the race will cancel your Entry Fee.

Supplemental Nominations: If the September 15th payment was NOT made, a Supplemental Nomination payment of \$350 plus the Nomination Fee and Entry Fee can be made at time of entry.

Declaration: All starters are to declare in by closing time listed on Condition Sheet. All horses must meet the Qualifying Standards of Prairie Meadows Racetrack & Casino at time of entry.

Money Division: Purses for races will be divided 45-25-15-10-5 percent.

Race Conditions: This event is to be raced at one (1) mile. Limited to ten (10) starters. If more than ten (10) horses are entered, preference will be given to horses with the highest 2011 earnings according to the U.S.T.A.

Rules: The rules of racing adopted by the Iowa Racing and Gaming Commission and Prairie Meadows Racetrack & Casino govern all races run at Prairie Meadows. Nominations to this stake are received only with the understanding that association reserves the right to refuse the nomination without notice to the subscriber. No nomination will be received except upon this condition. All disputes, claims, and objections arising out of the race or with respect to the interpretation of the conditions of any stakes shall be decided by the association or those whom they may appoint and their decision upon all points shall be final.

Purse: \$10,000 plus Added monies (Nomination & Entry Fees) and Iowa Supplement monies (for Iowa Registered Eligible Horses).
