ELIGIBILITY RULES

ELIGIBILITY DOES NOT IMPLY AUTOMATIC APPROVAL

"R0"-Zero Date: Horses will receive a zero (R0) preference date if foal registration papers and a current negative Coggins test are on file in the Racing Office by – **Wednesday, August 16, 2017 @ 4:00 PM.**

Health Certificate/Coggins/Piroplasmosis/EHV-1: All Quarter Horses and any pony horse, other than a Thoroughbred pony, must have proof of a negative test for Theileria Equi (Piroplasmosis). The test must have been performed within the past 365 days and include the tattoo number of the horse or an accurate description. A copy of the original test is acceptable. This requirement is for all Quarter Horses entering Prairie Meadows racetrack and includes any pony horse, other than a Thoroughbred pony. It is suggested that a copy of the test be attached to the foal papers in a manner similar to coggins tests. A current, negative coggins test is required of all horses, including ponies arriving at Prairie Meadows. The test certificates or copy thereof must be attached to the horse's foal papers and be filed in the Racing Office.

All horses, including ponies, shipping to Prairie Meadows must be accompanied by a valid health certificate issued within 7 days prior to arrival at the track, which shows the vaccination record for each horse. The horse must have been vaccinated with an FDA approved modified live or killed virus vaccine for EHV-1 not less than 10 days and not more than 60 days prior to date of entry and the veterinarian must provide the date of vaccination. A current, negative coggins test dated within twelve (12) months must also accompany the health certificate. Said documents must be presented at the stable gate upon arrival or horses will not be permitted to enter the stable area. Any questions regarding these requirements should be directed to either your practicing veterinarian or the Iowa Racing & Gaming Commission State Vet's Office.

Horses Shipping In To Race (not stabled on grounds): Horses shipping in to race **MUST** be on the grounds in their assigned stall no later than **11:00 A.M. or at least 4 ½ hours before the post time for the first race, whichever is earlier.** If for an unforeseen reason, the horse will not be on grounds prior to 11:00 A.M. or at least 4 ½ hours prior to post time for the first race, the trainer must contact the Stewards at 515-967-1201 to ask for permission to arrive late, and must contact a State Veterinarian at 515-240-8731 or 641-344-7230 or 630-632-1601 to make arrangements for a pre-race exam.

- 1) Horses that have started for a claiming price of less than \$2,500 will not be eligible to stable or race at Prairie Meadows unless they have won for \$2,500 or more since starting for less than \$2,500.
- 2) Maidens that have started for a claiming price of less than \$2,500 will not be eligible to stable or race at Prairie Meadows.
- 3) Maidens older than five (5) years old must have competed in a pari-mutuel race within 12 months of the race to be eligible to race at Prairie Meadows.
- 4) Horses over twelve (12) years of age will not be eligible to stable or race at Prairie Meadows.
- 5) All horses and ponies must have a current negative Coggins test certificate dated within 12 months when entering the stable area.
- 6) A Quarter Horse that has not started for a period of sixty (60) days or more shall be ineligible to race until it has completed a timed workout prior to the day of the race in which it is entered. The workout must have occurred on the grounds of a licensed facility within the previous sixty (60) days. First time starters must have at least two (2) approved timed workouts with one within the previous sixty (60) days; be approved to race by the starter, and have a published workout from the starting gate. Horses that have not started for a period of six (6) months or more must have two (2) published workouts, one of which must have occurred within the previous sixty (60) days.

STALL APPLICATION FOR PRAIRIE MEADOWS RACETRACK AND CASINO, INC. NOTICE

1. When sending in your stall application, please have the correct spelling of the horse's name. You **do not** need to send Past Performances.
2. It is **recommended** that all horses (including ponies) be on a current 90 day FDA approved EHV-1 vaccine or EHV-1 booster schedule.

RULES

1. The published rules and regulations of the Iowa State Racing Commission and the terms of any contract or arrangement in effect with the Iowa HBPA and/or Iowa Quarterhorse Racing Association shall apply to the meeting conducted by Prairie Meadows Racetrack and Casino, Inc. In consideration of stalls allotted at Prairie Meadows Racetrack and Casino, Inc. to the Applicant, the Applicant accepts the conditions and policies of racing established by Prairie Meadows Racetrack and Casino, Inc. from time to time during the Prairie Meadows Racetrack and Casino, Inc. meeting.

2. The rules of the Iowa Racing and Gaming Commission shall govern and control. All employees of the Applicant must be licensed by the Commission.

3. Each party to this Application shall be liable for its own acts and omissions as well as those of its agents, representatives, and employees to the same extent as would be applicable of provided at law without this provision.

4. Prairie Meadows Racetrack and Casino, Inc. reserves all rights to television and motion pictures filmed or produced. All entries will be accepted only on the condition that, if requested by Prairie Meadows Racetrack and Casino, Inc., the owner, jockey, trainer, groom and all other persons possible coming within camera view will sign a formal release permitting the filming of such television or motion pictures and the subsequent exhibition thereof.

5. In consideration of the allocation of stalls by Prairie Meadows Racetrack and Casino, Inc., sleeping quarters, hot and cold running water and electricity in stables and facilities located on the premises of Prairie Meadows Racetrack and Casino, Inc., the Applicant agrees to enter his or her horses when they are fit to run and suitable races are programmed, and the Applicant's horses will not be withheld as entries for any reason other than illness or inability to run for other valid cause. The Applicant agrees to vacate the stall or stalls allotted to him or her and remove all horses, equipment, and personnel from the premises of Prairie Meadows Racetrack and Casino, Inc. within 72 hours of being notified in writing to do so. Applicant further agrees that in the event Applicant fails to vacate any stall(s) as required by the foregoing sentence, Applicant will pay Prairie Meadows Racetrack and Casino, Inc. \$50.00 per day per stall not so vacated. Applicant further submits to being sued in the Polk County District Court for collection of any such charges.

6. The Applicant and all personnel under his or her control will refrain from smoking or using alcoholic beverages in the barn area. No cooking is allowed in or about the barns. No pets are permitted on the backstretch.

7. This Application shall not be construed as a lease of any particular space at Prairie Meadows Racetrack and Casino, Inc., but merely constitutes a revocable license of permit under the terms and conditions herein set forth. The signature of the applicant on this Application is an acknowledgment that the Applicant agrees to be subject to the above rules and conditions.

8. Applicant represents and warrants that during the term of this Agreement Applicant will timely pay and discharge in full all fees and expenses incurred in connection with the horses stalled at Prairie Meadows Racetrack and Casino, Inc., including but not limited to all fees and expenses owing to any vendor or veterinarian from whom Applicant purchased any goods or services.

9. Applicant acknowledges and agrees that Prairie Meadows Racetrack and Casino, Inc. may, with or without cause, trespass and remove Applicant from Prairie Meadows Racetrack and Casino, Inc.' facilities.

10. **Racing Disallowed.** No owners shall be allowed to race any horses owned by them in any races at Prairie Meadows Racetrack and Casino, Inc. during any period that they have unpaid indebtedness owed to Prairie Meadows Racetrack and Casino, Inc., and no trainers shall be allowed to race any horses trained by them in any races at Prairie Meadows Racetrack and Casino, Inc. during any period that they have unpaid indebtedness owed to Prairie Meadows Racetrack and Casino, Inc., in each instance for which Prairie Meadows Racetrack and Casino, Inc. has made a written demand for payment, which demand has not been **satisfied in full within ten (10) days of the date of the demand.**

WARNING

The undersigned represents that he/she is familiar with equine activities and that he/she understands that there may be numerous hazards and risks, known and unknown, to applicant, applicant's agents, owners, employees and invitees (the "Releasers") and to their property incidental to accepting stalls, practicing for and participating in horse racing and related activities at Prairie Meadows Racetrack and Casino, Inc. ("Prairie Meadows"). In consideration of the allotment of stalls at Prairie Meadows, the Releasers hereby waive, release and forever hold harmless Prairie Meadows, its officers, agents, representatives, employees, and others acting on behalf of Prairie Meadows (hereinafter collectively "Indemnified Parties") from any and all liability for any loss, damage, expense, destruction or injury to any person, horse, or other personal property owned, leased, or borrowed by, or in possession of, any of the Releasers, arising from or occurring on the premises of Prairie Meadows, whether caused by the negligence of any of the Indemnified Parties or otherwise. The Releasers agree to forever indemnify and reimburse the Indemnified Parties for any and all fees and expenses, costs or damages caused by or to any of the Releasers or any person, horse, or other property of the Releasers, while on the premises of Prairie Meadows.
